
"Griffith College has been at the forefront of innovative education provision, remaining relevant and responsive as society and the economy have evolved and changed in unexpected ways."

ACKNOWLEDGMENTS

As President of Griffith College, it is my honor to introduce this booklet commemorating 50 years of educational excellence.

Now known as Griffith College, I founded **Business and Accounting Training in 1974** to prepare students for the professional examinations of the Institute of Chartered Accountants in Ireland.

I am often asked why I decided to set up a private Higher Education institution 50 years ago. I was working in what was then Haughey Boland, now Deloitte & Touche, and had just qualified as a barrister and chartered accountant. The pass rate for the chartered examinations shortly after this time was only 12.5%. Many colleagues and friends were struggling and asked for help. I had given lectures in UCD on a part-time basis, so I began providing tutorials for these chartered students. Within 12 months, I was very happy to see their **pass rate improve to 50%**.

During the late 1970s and early 1980s, together with my co-directors Pierce Kent, Roderick Murphy and Frank Scott-Lennon, we established a strong reputation for excellence in teaching. Soon after, Reg Callanan joined us as Director of Professional Programmes, helping the College expand its offerings to include additional professional accountancy bodies, such as CPA, ACCA and CIMA. This growth was marked by remarkable achievements, particularly our students securing first place in both the final and penultimate examinations in 1983.


We started in rented rooms in Stephen's Green, St Catherine's School on Baggot Street and Milltown Park Jesuit College. Our acquisition of the historic barracks on **South Circular Road in 1991** enabled us to establish Griffith College.

Today, the profile of our student body stands in certain contrast to our first classes. While we continue to offer professional accountancy courses, our programmes now cover a wide range of disciplines. Through partnerships with over 140 universities and Higher Education institutions, we proudly welcome students from all over the world.

Without the dedication of over 400 staff members and specialists, the College would not have reached its current level of success. We will remain committed to nurturing prizewinning students who excel academically and carve out thriving paths in their careers.


DISTINGUISHED FELLOWSHIP AWARDS


Each year, Griffith College has the opportunity to present honorary awards during the graduation ceremonies in Dublin, Cork and Limerick campuses.



















































PROFESSIONAL EXCELLENCE AWARDS

The **Professional Excellence Award** was created in 2004 by Griffith College to recognise individuals who have made outstanding contributions to professional or educational development at a national level in Ireland.




























































DISTINGUISHED GRADUATE AWARDS

The Accountancy Faculty boasts an impressive track record of award-winning students who have thrived in their careers. As the largest and longest-established accountancy body in Ireland, Chartered Accountants Ireland plays a vital role in the profession. Meanwhile, the Association of Chartered Certified Accountants (ACCA) offers a globally recognised qualification that upholds the highest standards of professionalism. Here are our accountancy prize winners who ranked first, second or third in their ACA, ACCA and CPA examinations. They competed against students from other Higher Education institutions across Ireland and around the world, with some even ranking first place among over 500,000 students worldwide.

Students from the Journalism & Media Communications Faculty and the Creative Arts & Screen **Media Faculty** have consistently achieved success in the National Student Media Awards (Smedias) across all media categories and disciplines. This annual All-Ireland student journalism competition is organised by Oxygen.ie, a website dedicated to third-level students. Additional distinctions include student projects showcased at film festivals or art galleries, and awards won in photography competition organised by Fuji.


The **Design Faculty**'s prize winners have excelled in competitive arenas, displaying their remarkable talent and innovation. Griffith students regularly participate in prestigious contests against their peers, including those organised by the Institute of Designers in Ireland (IDI), which serves as a leading body in the design community and promotes excellence across various disciplines, such as graphic design, fashion design and interior architecture. These prizes are highly regarded within the industry and provide a platform for emerging designers to gain recognition for their work.

We are particularly proud on behalf of Karen Sutton and her team in the Law School on receiving the accolade of Law School of the Year at the 2024 Annual Law Awards. We also salute the Law Faculty on the prizes won by its students in the Law Society of Ireland (LSI) entrance examinations. The IILEX Frank Crummey Perpetual Award further celebrates outstanding accomplishment in legal education by rewarding students who have stood out academically. Through these opportunities, our prize winners not only showcase their legal expertise but also position themselves as future leaders in the field, ready to make meaningful contributions to the practice of law.

The Leinster School of Music & Drama (LSMD) has been an established examining body in Ireland since 1904. It is Ireland's largest independent music and drama academy and the only institution offering QQI-validated drama education programmes. Since its founding, the school has produced a diverse array of accomplished performers. The Excellence Awards were first introduced in 2004 to present a national competition for students taking LSMD-graded examinations.

Finally, the Higher Education and Training Awards (HETAC), the legal successor to the National Council for Educational Awards (NCEA), granted Higher Education awards based on criteria such as academic achievement, quality of teaching and the relevance of courses to industry needs.
