We do our best to give comfort to parents and students while a student is resident in Ireland. We make sure they are comfortable and well cared for. We offer a guardianship service for students who are under 18, during their time studying in Ireland, on behalf of their parents/ guardians. It is a requirement that students under 18 have an Irish based Guardian.

Limited Guardianship includes:

- Assistance with Guardianship Application Procedure
- Meet and Greet Service upon arrival.
- Immigration Assistance: The student is responsible for making their own appointment to register with the immigration authorities in Ireland.
 Equinox will accompany them to the appointment and make sure they have all the required documentation.
- Monthly contact with students Via Zoom
- Assistance with making Medical/ Dental appointments if required (Please note - all Medical/Dental costs are the students' expense)

- Attend College meetings on behalf of parents if required
- Available to assist a student in case of Emergency

Additional Charges:

- If a problem cannot be resolved by phone or e-mail and an in-person visit is required, then this is charged at a rate of €200.00 per visit plus expenses (agreed by both parties in advance)
- If extra private transfers are required €150- €200 each way. Includes assistance
 with check-in procedure etc. (Agreed by
 both parties in advance)

Application Fee: €250 Under 3 months: €500 From 3 to 6 months: €750

Full Academic Year (9 months): €1000

Please note: The Guardianship Fee for High School students under our care is €2800 + €250 Application Fee, which is a flat rate for the Academic Year.
