Our approach is to teach a whole new way of living by addressing family relationships, work attitudes, self-image, peer pressure, addiction and its causes, community relationships as well as a variety of other life skills.

Tiglin Carraig Eden (Housing and Aftercare supports)
Jigginstown Manor (After Care Residential Centre)
Tiglin No Buck's Cafe (Homeless Drop-in Centre)

Future projects include projects in after care, youth and community in our new facility Coolnagreina in Greystones, Tiglin Pathways to employment and the new South Africa Project.

Internship description:

As an established social care organization the intern would interact with vulnerable individuals throughout our various centers. This would vary from our students in rehabilitation, graduates in transitional housing, clients in a homeless drop-in center, employees and volunteers.

The role would also include developing media content through collaboration with our staff and volunteers in order to tell stories of our former graduates, promotional videos and similar projects that the intern would be interested in developing.

A suitable candidate should have experience in creative media, creating media content as well as proficient social skills.

Internship length:

The length of the internship would be entirely up to the intern although we recommend at least 9 weeks.
